Participation Qualifications

The international pavilion is open to overseas enterprises which meet the following criteria:

- Applicants shall be the companies legally registered over 3 years (including 3 years) by eligible law in any country or region other than mainland China. Copy of the Company Registration Certificate (with company stamp) or other valid certificates shall be submitted.
- Exhibitor shall accept and abide by "The Exhibition Manual of International Pavilion of the 108th Session of China Import and Export Fair"; And exhibits shall fall into "The Exhibits Category (International Pavilion Phase Three) of the 108th Session of China Import and Export Fair".
- Exhibits shall be produced in any country or region other than mainland China. Certificate of Origin shall be submitted.
- Only if the Exhibitor, prior to entering the Exhibition Area for setting up stands during the preparation period, present to the managing staff at site of the Organizer the customs clearance of all exhibits or other original documents such as ATA Certificate and submit relevant copies, can the Exhibitor enter Exhibition Area.

Participation Procedure

Exhibitor shall fill in the Participation Application Form and submit it together with requested documents such as copy of Business License and Certificate of Origin to the organizer before Aug 30, 2010. After receiving the application form and relevant documents, the organizer shall confirm the application with the applicant after approval. The organizer shall then deliver the Notice of Payment and the Service Guide for Exhibitors of the International Pavilion of the 108th Session of China Import and Export Fair; Within 3 workdays after receiving the Notice of Payment, the exhibitor shall pay to the account nominated by the organizer the total stand fees of the actual exhibition space; The organizer shall deliver Notice of Stand confirmation after receiving the remittance. All account shall be settled after closure of the Exhibition and the balance shall then be paid to either side as the case may be.
